

ARTICLES OF INCORPORATION OF RG THROWER, INC.

I, the undersigned incorporator, hereby associate myself together and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is RG THROWER, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the 28th day of October

ARTICLE III - PRINCIPAL OFFICE
