

**ARTICLES OF AMENDMENT
TO

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its Articles of Incorporation.

1. The name of the corporation is Mark, Fore & Strike Holdings, Inc. (the "Corporation") and its Document Number is P02000132483.
2. Article III of the Articles of Incorporation of the Corporation is hereby deleted in its entirety, and the following substituted therefor:

"Article III

The Corporation is organized for any lawful purpose permitted under the laws of the State of Florida and the United States of America.."

3. Article IV of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following substituted therefor.

"Article IV

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having a par value of one one-hundredth of a dollar (\$.01) per share."

4. Article VII of the Articles of Incorporation of the Corporation is hereby deleted in its entire and the following substituted therefor:

"Article VII

The initial director of the Corporation is Lawrence D. Autrey."

5. These Articles of Amendment were approved by the sole stockholder of the Corporation's common stock, which is the only group of the Corporation's shareholders entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for approval on January 13, 2003.
