

ARTICLES OF INCORPORATION OF FANTASTIC TOUCH BY OTT, INC.

The undersigned, who desires to form a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I-NAME

The name of this corporation is FANTASTIC TOUCH BY OTT, INC.

ARTICLE-II-DURATION

This corporation shall have perpetual existence commencing on January 1, 2003 at 12:00 A.M. after the filing of these Articles with the Department of State.

ARTICLE III-PURPOSE


