The name of the Corporation formed for these Articles of Incorporation will be TRIPTICO, INC.

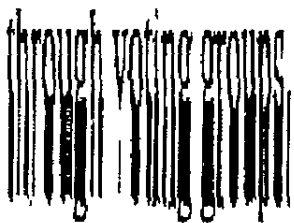
