The undersigned, acting as incorporator of Rey Sanchez & Associates, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.


#### ARTICLE VI AUTHORIZED SHARES

candidates. In voting on all other proposals, each shareholder having the right to vote shall be entitled to one vote for each share of voting stock held.


#### ARTICLE XII BYLAWS
