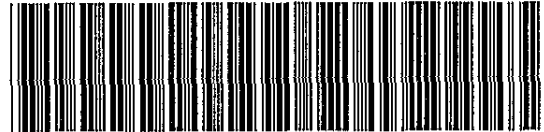

**ARTICLE I






