

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Lauren David Dale, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 6055 Sims Boca Road Boca Raton, Florida 33433

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
