

ARTICLES OF INCORPORATION
OF

ARTICLE I

PETE'S COIN LAUNDRY IV, INC.

The name of this corporation shall be PETE'S COIN LAUNDRY IV, INC..

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at:

ARTICLE III

DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV

PURPOSE

This corporation is organized for the following purposes:


