ARTICLES OF INCORPORATION OF TENTH CONCEPTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is TENTH CONCEPTS, INC. (hereinafter called the "Corporation").

ARTICLE II SPECIAL PURPOSE
