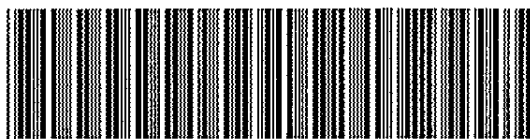

In compliance with requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Professional Association.

ARTICLE I

The name of the Professional Association is: "CORZO LAW, P.A."

ARTICLE II

The existence of this Professional Association shall begin upon the filing of these Articles.

ARTICLE III

This Professional Association is organized for the following purposes:

1. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this Professional Association.
