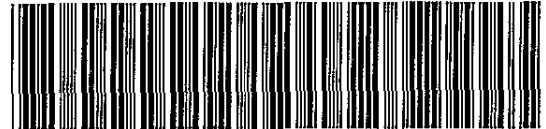

ARTICLES OF INCORPORATION


1. The name of the corporation shall be P.B.S. TRAFFIC SCHOOL INC.
