



The name of the corporation is HIG G. NEIL ACQUISITION CORP. (hereinafter called the "Corporation").

#### ARTICLE II

ARTICLE I

The address of the principal office and the mailing address of the Corporation is 1001 Brickell Bay Drive, 27th Floor, Miami, Florida 33131.

#### ARTICLE III

The Corporation shall have the authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.
