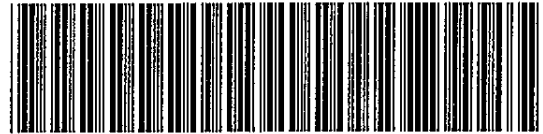

ARTICLE IX. AMENDMENT


