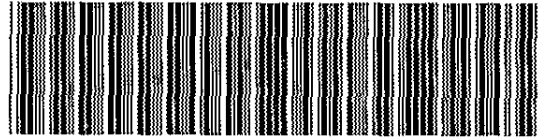

ARTICLES OF INCORPORATION

ARTICLE I - NAME
EFFECTIVE DATE 01/02/03
