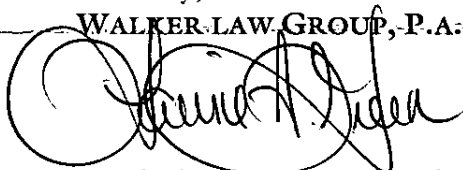
I enclose a completed application for Corporate Reinstatement regarding the referenced corporation along with payment (representing the annual fee) in the amount of \$150.00.
