**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
THE USA BOUQUET COMPANY (ATLANTA)  
a Florida corporation**

Pursuant to the Florida Business Corporation Act, Article 1 of the Articles of Incorporation of **The USA Bouquet Company (Atlanta)**, a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:

**ARTICLE 1 Name**

The name of the Corporation is **Working Employees II, Inc.**

In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this Amendment shall be effective upon its filing with the Florida Department of State.

The foregoing Amendment to the Articles of Incorporation of the Corporation was unanimously approved by the Corporation's directors and a majority of all of the shareholders on January 30, 2007, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.
