ARTICLES OF INCORPORATION

OF

(a Florida corporation)

Article I - Name

The name of the corporation is: H.R. HARKINS, INC. (hereinafter called the "Corporation").

The Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall


