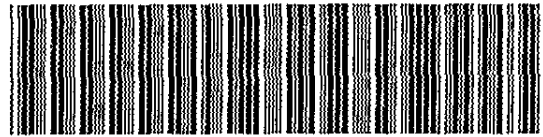

ARTICLE I

The name of the corporation is Silver Star Chiropractic Clinic, Inc. (hereinafter called the "Corporation").


ARTICLE VII

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.


