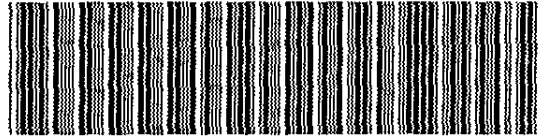



ARTICLE VIII: DIRECTORS






