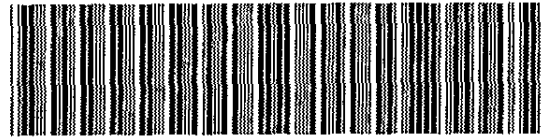

**Article I
NAME AND PRINCIPAL OFFICE OF CORPORATION**

The name of this corporation is INFINITY TECH SOLUTIONS, INC., and its principal office is located at 8700 Ramble Woods Drive, Pensacola, FL 32514, and its mailing address is P.O. Box 11367, Pensacola, FL 32524.

**Article II
PURPOSE**

The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are stated and declared to be as follows:

To enter into any business lawful under the laws of the State of Florida, either for its own account, or for the account of another, as agent, and either as agent or principal, to enter upon or engage in any kind of business of any nature whatsoever, in which corporations organized under Florida Business Corporations Law may engage; and to the extent not prohibited thereby, to enter upon and engage in any kind of business of any nature whatsoever, in any state of the United States of America, any foreign nation, and any territory of any country to the extent permitted by the laws of such state, nation or territory.

**Article III
CAPITAL STOCK**

The maximum number of shares of stock that the corporation shall is authorized to have outstanding at any time shall be 10,000 shares of stock with no par value.

**Article IV
DURATION**

The duration of the corporation shall be in perpetuity or such maximum period as may be authorized by the laws of the State of Florida, commencing upon the date of filing of these Articles of Incorporation.

**Article V
INITIAL OFFICERS/DIRECTORS**

Unless and until otherwise provided for in the by-laws, all of the corporate powers of this corporation shall be vested in, and all of the business and affairs of this corporation shall be managed by a Board of Directors of not less than one nor more than seven directors. The number of directors may be increased or decreased within the limits above provided by a majority vote of the Board of Directors.
