



ARTICLES OF INCORPORATION
OF
DENTAL LAB CONTRACTORS, INC.

ARTICLE I

The name of this Corporation shall be DENTAL LAB CONTRACTORS, INC.

ARTICLE II

This Corporation shall exist in perpetuity.

ARTICLE III

The general nature of the business to be transacted by this Corporation is to: Manufacture, purchase or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, foodstuffs, and services of every kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

ARTICLE IV

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of one dollar(\$1.00) per share.

ARTICLE V

The name of the registered agent is SUSAN E. FLANARY, and the street address of the initial registered agent is 902 N. W. Sunset Terrace, Stuart, Florida 34994.

The Registered Agent hereby affirms that she is familiar with and accepts the duties and responsibilities of Registered Agent for said Corporation.

ARTICLE VI

This Corporation shall have one director initially, the name of the initial director is SUSAN E. FLANARY, and her address is 902 N. W. Sunset Terrace, Stuart, Florida 34994. The number of directors may be increased or diminished from time to time by the By-Laws of the Corporation, but shall never be less than one director.

ARTICLE VII

ARTICLE VIII

ARTICLE IX

These Articles of Incorporation may be amended in the manner prescribed by law. Every amendment shall be approved by the Board of Directors, proposed to them by the Stockholders and approved at a Stockholder's meeting by a majority of the stock entitled to vote thereon, or by one of the Board of Directors and approved by such Board of Directors by a majority thereof, unless all of the Directors and Stockholders sign a written statement and agreement manifesting their intention that a signed statement shall signify

This preemptive right is limited to the extent that no fractional shares shall be sold or issued.

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.
