### ARTICLES OF INCORPORATION

OF

# TAX, ACCOUNTING AND FINANCIAL PROFESSIONALS, I

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

### ARTICLE I - NAME

The name of the corporation is TAX, ACCOUNTING AND FINANCIAL PROFESSIONALS, INC., and its principal office and mailing address is: 868 106<sup>th</sup> Avenue North, Naples, Florida 34108.

### ARTICLE II – NATURE

The nature of the business to be transacted by this corporation is: Tax Preparation, Accounting and Professional Services. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds. To buy, sell, mortgage, lease, let, hold for investment or otherwise, use and operate real estate of all kinds, improved or unimproved; and any right or interest therein.

To manufacture, purchase, or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of very class, kind and description, except that it is not to conduct a banking business, safe deposit trust, insurance, surety, express, railroad,

canals, telegraph or telephone or cemetery, a building and loan association, fraternal benefit society, state fair or exposition.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness, execute mortgages, and transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidences of indebtedness created by other corporation, and while owner of such stock, to exercise all rights, powers and privileges of ownership, including the right to cote such stock. To purchase its own capital stock from earned surplus.

To engage and deal with the directors of this corporation or its officers in contracts or otherwise, and in the absence of fraud, no director or officer of this corporation shall be disqualified from arms length transaction with this corporation.

### ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is FIVE HUNDRED (500) having a ONE DOLLAR (\$1.00) Par Value of Voting Common Shares, and FIVE HUNDRED (500) having a ONE DOLLAR (\$1.00) Par Value of Non-Voting Preferred Shares. The consideration to be paid for each share shall be in money, property or services as determined by the Board of Directors.

### ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is not less than FIVE HUNDRED DOLLARS (\$500.00).

### ARTICLE V – TERM OF EXISTENCE

The corporation is to exist perpetually.

### ARTICLE VI – ADDRESS
