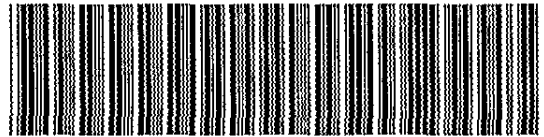

ARTICLE I. NAME

The name of the corporation shall be ADVANCED SURFACING, INC.

ARTICLE II. ADDRESS
