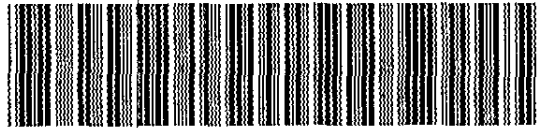




The name of the corporation is changed to:
