

ARTICLE I

The name of this corporation shall be Sky Home Investments, Inc.

ARTICLE II

The principal office and mailing address of this corporation shall be 5417 Kennedy Hills Dr., Seffner, FL 33584.

ARTICLE III

This corporation is formed for the purpose of conducting any business or business transaction lawfully permitted by the Florida Business Corporation Act.

ARTICLE IV

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 1,000 shares of common stock, with a par value of \$1.00 per share, the consideration for which may be paid by money, property, or services as may be fixed by the board of directors from time to time.

ARTICLE V

The initial registered office of this corporation shall be located at 5417 Kennedy Hills Rd., Seffner, FL 33584, and the initial registered agent of this corporation shall be Kristie L. Simpson, who is familiar with the obligations of that position and whose

This corporation shall have perpetual existence.






