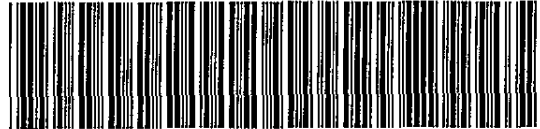

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. Name. The name of the Corporation is GLOBARB, INC.

ARTICLE VIII. Indemnification of Officers, Directors, Employees and Agents.




