# ARTICLES OF INCORPORATION OF DAVID L. DAY ENTERPRISES, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name
