The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **Edward J. Houdek, Jr., P.A., Inc.** and its principal office and mailing address is: **2265 Harmony Lane #101, Naples, FL 34109.**

<u>ARTICLE II - NATURE</u>

The nature of the business to be transacted by this corporation is: real estate sales.
