**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this Corporation is THE WHITE DOG MANAGEMENT COMPANY.


#### ARTICLE X - INDEMNIFICATION

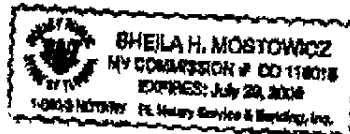
