

ARTICLES OF INCORPORATION

OF

MELCO BUILDING SYSTEMS, INC.

I. NAME

The name of the corporation is MELCO BUILDING SYSTEMS, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

III. NATURE OF BUSINESS
