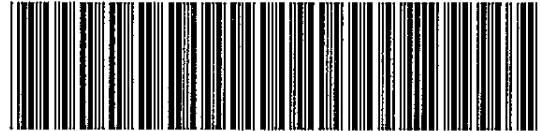


ARTICLE TEN


ARTICLE ELEVEN


