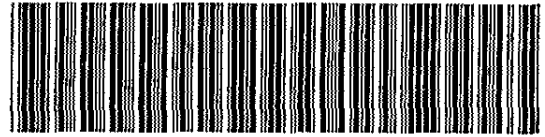

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Article of Amendment to its Articles of Incorporation:*

**FIRST:** Amendment(s) adopted: Article IV is being amended as follows:  
The original 100 shares of stock are being distributed as follows:  
Neil Gershkon will hold 60 shares  
Carol Gershkon will hold 40 shares

**SECOND:** If an amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself, are as follows:

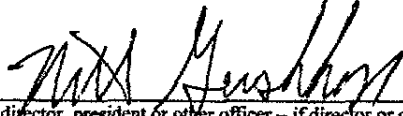
