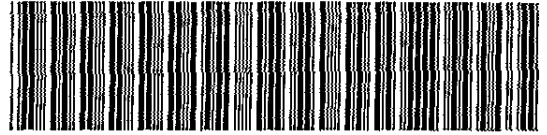

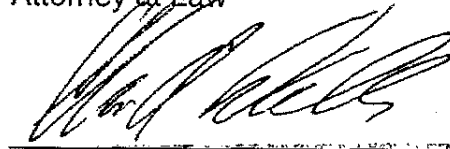

ARTICLES OF INCORPORATION

OF

S & B OF ZEPHYRHILLS, INC.

A Florida Profit Corporation

(Pursuant to Chapter 607 and 721, Florida Statutes)

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

1. **Name.** The name of this corporation is S & B of Zephyrhills, Inc. The period of duration shall be perpetual.
2. **Purpose and Powers.** This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

This corporation shall have the broad general powers set forth in s. 607.0302, Florida Statutes and the purpose for which this corporation is organized is:

To run, operate and manage a Laundromat with its associated businesses.

3. **Authorized Capital.** The corporation shall have the authority to issue One thousand shares of common stock. The par value of the stock is \$1.00.
4. **Principal Place of Business.** The principal place of business and mailing office of the corporation shall be:

38022 Winter Drive, Zephyrhills, Florida 33542.

5. **Board of Directors.** The number of directors of the corporation shall be fixed and may be altered from time to time as may be provided in the bylaws but in any event shall consist of no fewer than one member. In case of any increase in the number of directors, the additional directors may be elected by the directors or by the shareholders at an annual or special meeting, as shall be provided in the bylaws.

The initial Board of Directors shall consist of No less than 2 nor more than 5 persons, who shall serve until the first annual meeting of the shareholders, and whose names and addresses are:

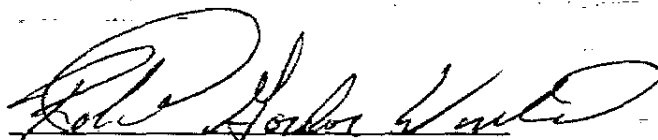
