**Article I**

**NAME**

**Article II**

**DURATION**

The Corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of State.

**Article III**

**NATURE OF BUSINESS**

The Corporation may engage in any activity or business permitted under the laws of The United State, the laws of The State of Florida, and the teaching of the arts, including but not limited to: painting, sculpture, drama, dance, computer science, music, etc..

**Article IV**

**CAPITAL STOCK**
