ARTICLE I - NAME

The name of this Corporation is MONROE COUNTY COLLECTIBLES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of these Articles.

This Corporation is organized for the following purposes:


ARTICLE X - INDEMNIFICATION



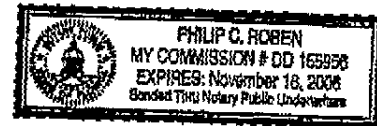
