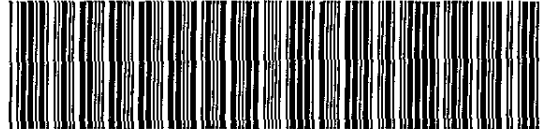



33432-5809. The initial registered agent of the corporation at that address shall be AUDREY B. SCHNEIDERMAN.




