# ARTICLES OF INCORPORATION OF ROBERT W. SNEYERS, P.A.

THE UNDERSIGNED natural person, who is licensed Real Estate Agent in the State of Florida hereby expresses the intention of forming a PROFESSIONAL CORPORATION in accordance with the Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such Corporation:

#### ARTICLE I. NAME

The name of the Corporation is Robert W. Sneyers, P.A.

#### ARTICLE II. DURATION

The period of the Corporation's duration shall be perpetual or until dissolved on a vote of Shareholders as hereafter provided.

#### ARTICLE III. PURPOSE

The purpose of the Corporation is to counsel clients about the purchase of and to sell real estate to clients.

## ARTICLE IV. CAPITAL STOCK

The total number of shares of Capital Stock which the Corporation shall be authorized to issue is 1,000 shares. Such shares shall be of a single class of Common Stock and shall have a par value of one dollar (\$1.00) per share.

#### ARTICLE V. CAPITALIZATION

The amount of capital with which the Corporation will have at the beginning is not less than Five hundred dollars (\$500.00).

#### ARTICLE VI. PRINCIPAL OFFICE

#### ARTICLE VII. CORPORATE POWERS

The Corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

#### ARTICLE X. BY-LAWS

The Corporation may be dissolved at any time (1) by a unanimous written consent of the shareholders; or (2) on the affirmative vote of at least two-thirds of the outstanding shares of the Corporation entitled to vote thereon. On dissolution, the

corporate property and assets shall, after payment of all debts of the Corporation, be distributed to the Shareholders pro rata, each Shareholder to participate in the distribution in direct proportion to the number of shares held by the Shareholder.


