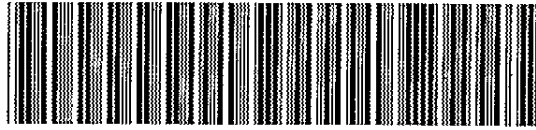

The name of this corporation is KIA, INC.
