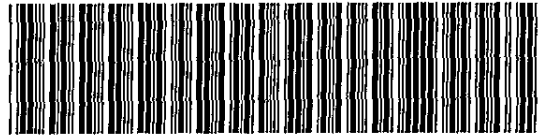

Purposes

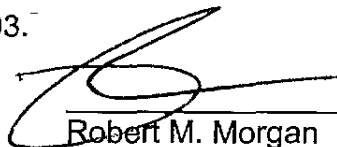
The purpose of this entity is to conduct all services and business permitted by licensed real estate sales persons and brokers.
