ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is TONY G. CONSULTING SERVICES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing as of December 30, 2002.

ARTICLE III - BUSINESS AND PURPOSE


