
ARTICLE X - INDEMNIFICATION

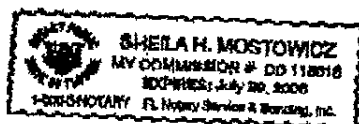


