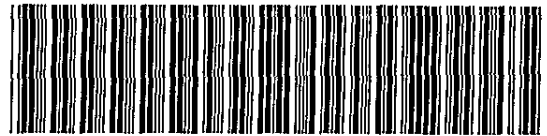

Name of Corporation

United Concrete Enterprises, Inc.

ARTICLE II
Business of Corporation

The corporation may engage in the business of concrete construction and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Capital Stock

COMPENSATION

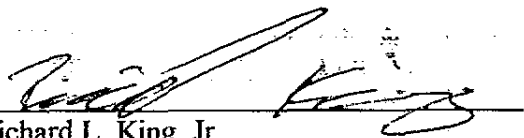
The board of directors shall have the power to set the amount, if any, of the compensation to be paid to the directors of the corporation.

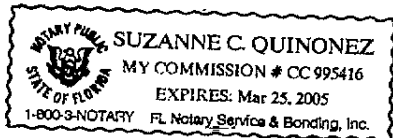
