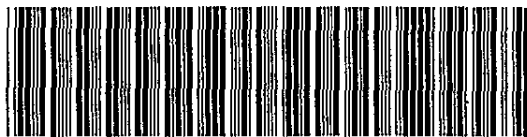




- FIRST: The name of the Corporation as currently filed with The Department of State is: S&B Referrals, Inc.
