The effective date of the Withdrawal shall be October 31, 1999.

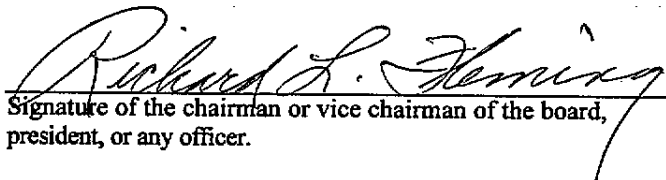
