**ARTICLES OF INCORPORATION
OF
CSD Computing, Inc.**

The directors and shareholders of CSD Computing, Inc., a Florida corporation (the "Corporation") have duly adopted the following Articles of Incorporation on December 30, 2002 pursuant to the provisions of Sections 607.0704, 607.1003 and 607.1007 of the Florida Business Corporation Act:

ARTICLE I.

The name and address of the Corporation shall be CSD Computing, Inc.

ARTICLE II.

The principal place of business and mailing address of the corporation is 6596 NW 78th Drive, Parkland, Florida 33067. This Corporation shall have perpetual existence.

ARTICLE III.

The general purposes for which this Corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, as amended, and to engage in any trade or business which, in the opinion of the Board of Directors for the Corporation, can be advantageously carried on in connection with the foregoing business.
2. To do such other and further things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
3. To carry out any business, occupation, undertaking, enterprise and exercise any power or authority which may be done by a private corporation organized and existing under and by virtue of Chapter 607, Florida Statutes, as amended, it being the intention that this Corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as amended.

ARTICLE IV.

The total number of shares of all classes of capital stock which the Corporation shall have the authority to issue is 100 shares of Common Stock with a par value of \$.001 per share (the "Common Stock").

ARTICLE V.

The Board of Directors of the Corporation shall consist of at least one Director, with the exact number of Directors to be fixed from time to time in the manner provided in the Corporation's Bylaws. The name of its initial Board of Director and Corporate Officer (President, Secretary & Treasurer) is Craig S. Davis at 6596 NW 78th Drive, Parkland, Florida 33067.

ARTICLE VI.

The street address of the registered office, of the Corporation is: 6596 NW 78th Drive, Parkland, Florida 33067 and the name of its registered agent at such address is Craig S. Davis.

ARTICLE VII.

The name and address of the incorporator signing these articles is Craig S. Davis at 6596 NW 78th Drive, Parkland, Florida 33067.

ARTICLE VIII.

A. Indemnification of Officers and Directors. The Corporation shall indemnify any Officer or Director who by virtue of his being an Officer or Director of this Corporation, is made a party to any action or proceeding to the fullest extent permitted by Florida law.

B. Officer and Director Liability. No Officer or Director shall be liable to the Corporation for any loss or damage suffered on account of any action taken or omitted in good faith if such Officer or Director exercised the same degree of care that a prudent person would have exercised in the conduct of his or her own affairs.

C. Reimbursement of Officers and Directors. In any action or proceeding brought by or on behalf of the Corporation against an Officer or Director, which results in a decision in favor of the Officer or Director, the Corporation shall reimburse the Officer or Director for all reasonable expenses incurred by him or her in the course of the action or proceedings.

ARTICLE IX.

The Directors shall not be liable for illegal dividends or distributions made by the Corporation, unless willful or negligent, if based on good faith reliance on representations made by officers or agents or records as to the financial condition of the Corporation.
