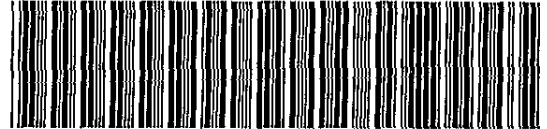

ARTICLE II

This corporation shall have a perpetual existence.
