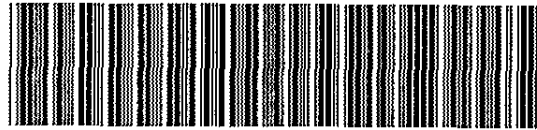

ARTICLE 6. CORPORATE EXISTENCE

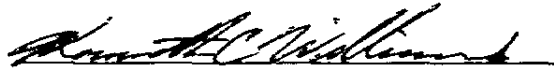

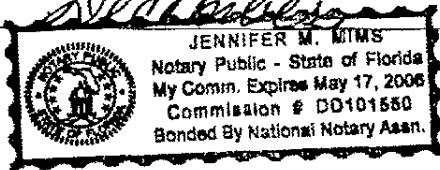

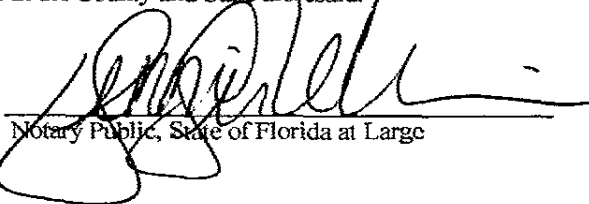
