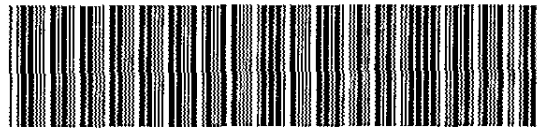

The undersigned, acting as incorporator of a Florida corporation under the Florida Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Robert A. Dressler, P.A.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of the Corporation is 1215 E. Broward Blvd., Suite 201, Ft. Lauderdale, Florida, 33301. The current mailing address of the Corporation is P.O. Box 2425, Ft. Lauderdale, Florida 33303-2425.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of engaging in the practice of law as governed by the Supreme Court of Florida, and taking all actions that are necessary and proper in connection with that practice.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue One Hundred (100) shares of common stock One Dollar (\$1.00) par value per share.

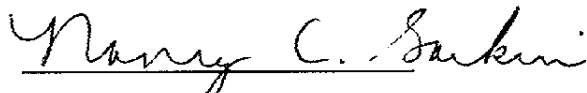

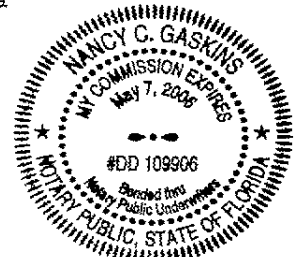

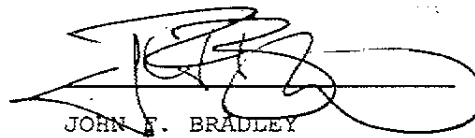
