ARTICLES OF INCORPORATION OF

CHERI A. BURR INCORPORATED, INC.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: CHFRI A. BURR ICNORPORATED, INC. The principal place of business of this Corporation is: 131 Nottingham Rd., Royal Palm Beach, Florida 33411, which is the same as the registered office of this Corporation.

ARTICLE II

This Corporation shall have perpetual existence commencing of the filing of these Articles.

ARTICLE III

PURPOSE

The general purpose for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purpose of the Corporation or necessary or desireable in order to accomplish them.
- c. To engage in the operation of a business dedicated to the practice of medical transcription and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is Five Thousand (5000) Shares of

common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE V

REGISTERED OFFICE AND AGENT

ARTICLE VI

BOARD OF DIRECTORS

The number of directors constituting the initial Board of Directors for this Corporation is one (1). AMENDMENT

Every amendment shall be approved by the Board of Directors, proposed by them to the Stockholders and approved at a Stockholders' Meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE IX

,INDEMNIFICATION

The Corporation shall indemnify each officer and director, including former officers and directors, to the full extent permitted by law.

ARTICLE X

BY-LAWS

The power to adopt, alter, amned and repeal the by-laws shall be invested in the Board of Directors, but all alterations, amendments and repeals of the by-laws must be approved by a majority of the stockholders.
