



The undersigned for purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is **in.video productions, inc..**

**ARTICLE II - INITIAL PRINCIPAL OFFICE**

The corporation shall have its principal office at 5501 Pinnacle Ln., West Palm Beach FL 33415

**ARTICLE III - CORPORATE PURPOSE**


